- 2) In a situation of disqualification of a candidate, such candidate may proceed for an appeal to look into the matter at the national headquarters. In this case, a panel of five (5) members shall be set to sit on the matter at Accra. Such a request for an appeal must be written to the office of the General Secretary of the party with a non-refundable fee of Two Hundred Ghana Cedis (GH¢200.00) after which a date shall be set and duly communicated to the appellant (in this situation, the candidate) for a final decision by the party. A candidate may only go to a court of competent jurisdiction on this issue only after exhausting these channels and still not satisfied.
- 3) Where two or more candidates qualify for the position of the same office,
 - a. The national executive committee can decide
 - b. There shall be an election by certified / approved delegates by the party hierarchy.

(Note: Number of delegates does not matter)

- c. The party can consult the candidates and amicably choose one of them.
- d. Applicant must have his party dues fully paid from 2020 to date
